At 1:14P 10-21-82, KENNETH LLOYD KING was warned by Judge Q. Z. VALENTINE, Waco Municipal Court. Warning form was filled out and will be attached to the original case in Records.

This Warning Form was for a Polygraph exam conducted by Sgt. JOHN SHERRILL.

At approx. 1:30P 10-21-82, Sgt. SHERRILL did start the Polygraph exam in reference to KENNETH KING's possible involvement in this murder and to verify his whereabouts on & about 7-13-82.

After the Polygraph exam was finished, Sgt. SHERRILL said that he did not show any deception in answering the questions. The questions were centered around KENNETH KING's stating that he left for SALADO for a four day work shop being conducted at the STAGECOACH INN in SALADO. He left Waco earlier enough to get to SALADO at 9:00 in the morning, for a program that he was going to, that lasted until approx. 4:30PM 7-13-82. After the class was dismissed at 4:30P 7-13-82, KING went to his room and attempted to hook up his Video Recording machine to the TV in that room, however found that the TV in his room would not work. The Video tape machine was going to be used for programs that HE was going to put on Wednesday morning, as well as Wednesday afternoon and Thursday morning. KING did contact RICHARD FRANKS shortly after 4:30 by phone and advised him that the Television in his room was not working and that RICHARD FRANKS might have to bring a Television from his address to SALADO or somewhere in between. KING did find that there was a maintenance man at the STAGECOACH INN that might possibly be able to find a television set that would work, but would not be available until approx. 7:PM 7-13-82.

KENNETH KING did contact RICHARD FRANKS between 7 & 7:30PM on 7-13-82 and advised him that he had found a television set and there would be no reason for RICHARD FRANKS to come South to SALADO or TEMPLE area and bring a television with him.

At approx. 9:30 to 10:AM on Wednesday 7-14-82, KENNETH KING received a phone call from RICHARD FRANKS, advising him that KEN FRANKS had been missing. RICHARD FRANKS said it was a very short call & that he was in the middle of his program when the call was made there at his room in the STAGECOACH INN & did not talk with RICHARD FRANKS very long. KENNETH KING did call RICHARD FRANKS, during the first break and did find that RICHARD was upset but the conversation was detailed other than the fact that RICHARD FRANKS believed that something bad had happened to

Approx. 9:PM KENNETH KING received a call from Judge SMITH, advising him that KENNETH FRANKS, along with the two females had been found and that after hearing this, KENNETH KING did drive back to Waco from SALADO.

The questions that were asked to KENNETH KING by Sgt. SHERRILL were of the nature that if he had anything to do with the murder or knew who did it or was there, that it should have shown some deception, however the chart, according to Sgt. SHERRILL showed that KENNETH KING had no knowledge of the murders.
