

1 THE COURT: Mr. Glazer, I remind you that  
2 you are under oath.

3 THE WITNESS: Yes, Your honor.  
4

5 JERRY GLAZER,

6 being called as a witness on behalf of the State and  
7 after having been duly sworn, was examined and testified  
8 as follows:

9 DIRECT EXAMINATION

10 BY MR. WALSH:

11 Q State your name.

12 A Jerry Glazer.

13 Q How are you employed?

14 A I'm sergeant criminal investigator with Williamson  
15 County Sheriff's Department.

16 Q How long have you been employed with the Williamson  
17 County Sheriff's Department?

18 A A year and a half.

19 Q I'm going to hand you two exhibits which have been  
20 marked State's Exhibit 14 and State's Exhibit 15,  
21 and ask you if you have seen those exhibits before.

22 A Yes, sir, I have.

23 Q On January 17th of 1984, did you receive these  
24 exhibits from Ray Hardison?

25 A Yes, sir, I did.

1 Q On that same day, did you deliver these to the DPS  
2 Lab in Austin?

3 A Yes, sir, I did.

4 MR. WALSH: Pass the witness.  
5

6 CROSS-EXAMINATION

7 BY MR. HIGGINBOTHAM:

8 Q What were the dates, Mr. Glazer, that you received  
9 them; do you recall?

10 A It was January 17th, 1984.

11 Q Who did you receive them from?

12 A Ray Hardison.

13 Q And what did you do with them?

14 A Took them to the DPS Laboratory in Austin.

15 Q Who did you give them to there?

16 A The man in charge of latent prints.

17 Q Do you recall his name?

18 A No, sir, not right offhand.

19 Q And then when did you pick them back up?

20 A I did not pick them back up, sir.

21 Q At any time did you receive any reports; did  
22 anybody give you any reports concerning these?

23 A No, sir.

24 Q So what you're saying is that Ray Hardison gave  
25 them to you and you took them down to DPS.

1 A Yes, sir.

2 Q And that's all you know about this particular piece  
3 of evidence.

4 A Yes, sir, that's correct.

5 MR. HIGGINBOTHAM: Pass the witness.

6 MR. WALSH: Nothing further.

7 THE COURT: May the witness be excused?

8 MR. HIGGINBOTHAM: Yes, sir.

9 MR. WALSH: Yes.

10 THE COURT: All right. You're excused to  
11 go about your business.

12 THE WITNESS: Thank you, sir.

13 (The witness, Jerry Glazer was excused.)

14 MR. WALSH: The State calls Bobby  
15 Donaldson.

16 THE COURT: Have a seat, Mr. Donaldson.  
17 I remind you that you are under oath.

18 THE WITNESS: Yes, sir.
