Received a call out there on a questionable death, finding three bodies. DET. SALINAS was called out as well as other officers, at which time I worked the special on the incident. I took measurements from the bodies to the dirt roads & from the distance of the dirt roads back to a paved road, which is in Speegleville 3, called area 15 and the paved road measurements from is called Park Road #3. Also took measurements from the dirt roads down to the lake to find my location for fixed areas and the wooded area to take measurements from. I also took photographs, approx. total of around 72 photographs as follows:

- PHOTOGRAPHS OF VICTIM #1 BEING THE WHITE MALE. SUBJECT HAS BEEN IDENTIFIED AS A KENNETH FRANKS, W/M 18 YEARS OF AGE.
- 15 PHOTOGRAPHS TAKEN OF A LAYOUT SCENERY THAT GOES IN A 360 DEGREE TURN, COVERING AROUND THE AREA OF VICTIM #1
- PHOTOGRAPHS, CLOSE-UP OF VICTIM #2, THIS BEING A BLOND FEMALE. THIS FEMALE'S NAME IS RAYLENE RICE, W/F 17 YEARS OF AGE.
- PHOTOGRAPHS, BEING A SCENERY LAYOUT OF APPROX. 180 DEGREE TURN AROUND VICTIM #2
- PHOTOGRAPHS OF VICTIM #3, THIS BEING A BRUNETTE FEMALE BY THE NAME OF JILL MONTGOMERY.
- SCENERY LAYOUTS IN A 180 DEGREE TURN AROUND VICTIM #3.
- 15 LAYOUT SCENERIES, GOING IN APPROX. 180 TO 200 DEGREE TURN BETWEEN VICTIM #2 & #3.
- PHOTOGRAPHS SHOWING PATHWAY DOWN THE DIRT ROAD.
