While working security at Providence Hospital, on 7-17-82, I was contacted by Head Emergency room nurse, GEORGE GUMBERT. He stated that on the same night of the Murders, that occurred in Speegleville, a man came in with an injury to his hand. The man, ALFRED SMITH (W/M 12-12-51, vy set, address of 3425 Wood, no phone, PD#18841 works for Cullins Salvage), had a cut on right hand. SMITH told DR. DOVALE that he was fishing at TP&L Lake and was walking down embankment when he fell forward, piercing his hand on a metal shaft, sticking in the ground. DR. DOVALE said that the entry would be clean cut and the exit wound was jagged, gave the impression of a bullet exit wound. DR. DOVALE said that it was not a bullet wound, that it was some kind of puncture. X-rays were taken and blood test were done. DR. ETHRIDGE did the surgery on SMITH. ETHRIDGE told GEORGE GUMBERT that the wound was clean cut so that it could have been a knife involved. GEORGE started thinking about the murders and also about the time SMITH came in with his injury, he felt like this could have some benefit to the case. GUMBERT also added that he was told that the subject had scrapes all about his body, look like he had been crawling around in some bushes. SMITH is in room #440 at Providence Hospital. Information about the address, etc., was obtained from the emergency room record and will be made available to follow-up detective.
