SGT. DENNIS BAIER and I were assigned to do a follow-up investigation on this case on Friday, 9/11/82. On Saturday morning, 9/12/82, we developed what we felt was a possible SUSPECT who received information of violent arguments between this individual and KENNETH FRANKS. We also received information from several sources of statements made by the SUSPECT about the murders after they had occurred, which statements detail how the offense was committed enough to cause suspicion. We also received information from a source that the SUSPECT had stated to the person and other persons present, that he, the SUSPECT, had killed the three people. We also received information on the afternoon of Monday, the 13th, that the SUSPECT was going to leave town on this night. A meeting was held in the Chief's Office which was attended by MYSELF; SGT. BAIER; Chief SCOTT; RICHARD CARTER, Legal advisor for the Police Dept.; Capt. RODRIGUEZ and Assistant DA BRAD CATES. After discussing the information that we had obtained, both RICHARD CARTER and Assistant DA BRAD CATES determined that we had sufficient probable cause for an arrest warrant. An affidavit was drawn up and signed by me. The affidavit was presented to Justice of the Peace JOHN CABINESS by MYSELF where he issued a warrant for the arrest of MUNEER MOHAMAD BEEB, W/M, 23, for the offense of murder. The SUSPECT BEEB was arrested at 11:30P at his store at 1423 Herring. Justice of the Peace JOHN CABINESS came to the Police Bldg. where he gave statutory warning to BEEB at 11:56P. A detailed report of the information obtained by MYSELF and SGT. BAIER in this case will follow.
