DETAILS

At 2:15PM, this date, I met McLennan County Sheriff's Office Sgt. Willingham at FM2063 and FM 2113 in Hewitt. He was ordered to serve Ed Graf, Jr., with divorce papers and a temporary Restraining Order. He followed me to 505 Angel Fire, where he served the papers to Graf with me present. After Sgt. Willingham departed, I told Ed I wanted to talk to him some more about the fire to which he agreed readily. At that time, Officer Colwell arrived at 505 Angel Fire, followed by Mrs. Graf and another motor vehicle occupied by three(3) white males who were going to help her remove some of the boy's items and some of her personal items from the house. ED also readily agreed to this. Officer Colwell and myself waited at the residence until Mrs. Graf was through, then had Ed Graf meet us at the station.-----

In the C.I.D. Office, myself and Officer Colwell again advised Ed Graf, Jr., of his rights then spent approximately 1½ - 2 hours listening to his story of what happened immediately after he discovered the fire and asking him more probing and pointed questions involving the overall case. The interview was recorded on the sound track of a video tape (VHS). The interview was from 3:30PM to 6:15PM.-----

DETAILS
At 12:45Pm this date, I contacted HOWARD HEMPEZ, Regional Claims/Personnel Policies Manager

of State Farm Insurance Co. in Dallas (214-248-5344). Mr. Hempel was able to give me confirmation of employee Edward Graf, Jr.'s Company Group Life Insurance Policy. He told me Graf had \$3,600.00 Life Insurance on each of his children, plus Accidental Death Benefits of \$10,000.00 each on each of his children. If his children died from accidental death, the total benefit on children so dying would be \$13,600.00 each.

Joey Proter, Deputy State Fire Marshal, told me he'd obtain copies of the two(2) known Life Insurance Policies of the Graf Children Monday morning. After confirming the two(2) known policies on the children - which are the only policies Mrs. Graf said she knew about; and which are the only policies Ed Graf says he had on the boys, the total accidental death benefits the Graf's stand to collect amount to \$63,600.00 on each dead child; or a total of \$127,200.00 for the deaths of Mason and Joby.
