Mrs. Pack, you will be excused. Thank you, 1 Ma'am. 2 (Whereupon, a short recess was had, 3 (after which the hearing continued as (follows, to-wit: 4 THE COURT: All right. Back on the record. 5 Darvin, raise your right hand. 6 (Whereupon the witness was sworn. 7 Are you Darvin Pack? 8 THE WITNESS: Yes, sir. 9 THE COURT: All right. I want the record to 10 reflect that we are outside -- in the Court's Chambers, 11 all the parties are present, including the Defendant. 12 This is a hearing on the Motion to Dismiss under the 13 Speedy Trial Act and in reference to the Motion to 14 Ouash a Subpoena that has been issued for you. And the 15 Court is going to determine the relevancy of it. 16 All right. 22	0	Okay. That was the only time you were in the courtroom?
23	A	I was there about half a day.
24	Q	Okay. Do you recall how long the trial lasted?

1	Ó	Were you there throughout the entire trial? That's what
2		I'm getting at.
3	A	Yeah.
4	Q	Okay. You didn't testify the entire time, but you were
5		there the entire time?
6	A	Uh-huh.
7	0	While you were present in the courtroom, were you aware
8		of the presence of Mr. Richard Franks in the courtroom?
9	A	(Shaking head.)
10	0	Do you know who Richard Franks is?
11	A	I met him once.
12	Q	When did you meet him?
13	A	After the Court
14	Q	Excuse me?
15	A	After the
16	Q	After the trial?
17	A	Yeah. After the trial.
18	Q	Describe to me the circumstances under which you came to
19		meet Mr. Franks?
20	A	Standing out in the hall.
21	Ó	Did he introduce himself to you?
22	A	Yeah.
23	Q	Okay. Did he tell you why he was wanting to meet you?
24	A	Uh-huh.
25	Q	Okay. Do you recall what you all talked about?

1	A	I didn't have nothing to say. He just told me his name.
2	0	That's all he said to you?
3	A	Uh-huh.
4	Q	Okay. Now, at the time of the Aggravated Sexual Abuse
5		trial, were you aware that David Wayne Spence was a
6		suspect in any other cases?
7	A	Uh-huh.
8	Q	Had you been told by any member of the District Attorney
9		Office that he was a suspect in any other cases?
10	A	(Shaking head.)
11	Q	Were you speak up for the record.
12	A	No.
13	Q	Were you aware that he was a suspect David Wayne
14		Spence was a suspect in the lake murders?
15	A	Uh-uh.
16	0	Had you heard that around the Courthouse?
17	A	Uh-uh.
18	Q	Did Mr. Franks tell you that?
19	A	No.
20		MR. FULLER: No further questions, Your Honor.
21		MR. BUTLER: We have no questions.
22		THE COURT: All right. I'm going to grant the
23		Motion to Quash the Subpoena.
24		You will be excused, Mr. Pack, and you will be
25		able to leave the Courthouse. Thank you, sir.
